**Time:** Wednesdays 3:00 - 6:00 pm June 2nd through October 13th, 2021  
*Setup begins 1:00 p.m.; must be present by 2:30 p.m.*  
*No sales before 3:00 p.m. market bell*  
*Must remain set up and continue selling until 6:00 pm*

**Place:** Court Street Plaza (Court and Resort Streets), downtown Baker City

To participate in the Baker City Farmers Market, you must submit:

- 1) 2021 Membership Application and \$15 fee (available online: <https://www.bakercityfarmersmarket.com/membership>)
- 2) Signed 2021 vendor, community, or kid's table market agreement
- 3) All applicable licensing and insurance documentation
- 4) Applicable market stall fee (see below for categories and rates)
- 5) Signed Double Up Food Bucks agreement, if eligible, available online in [English](#) <https://form.jotform.com/FarmersMarketFund/VendorAcknowledgment> and [Spanish](#) [https://form.jotform.com/FarmersMarketFund/VA\\_esp](https://form.jotform.com/FarmersMarketFund/VA_esp)

**Rates:**

- **Membership (annual; required):** \$15.00 (*due 3:00 p.m. at your first market*)
- **\*Daily single stall rate:** \$20.00 (*due 3:00 p.m. day of market*)
- **Seasonal single stall rate: \$17.00 x 20 weeks = \$340.00** (*due in full 3:00 June 3rd; designated seasonal stall location may be held with 50% seasonal payment (\$170.00) due at annual vendor's meeting; remainder is due prior to first market*)
- **\*\*Daily beginning vendor stall rate:** \$10.00 (*due 3:00 p.m. day of market*)
- **\*\*Daily community stall rate:** free
- **\*\*Daily kids table:** free

\*Daily stalls available on a first-come basis depending on available space. Please contact the market manager prior to market if you plan to attend.

\*\*Beginning vendor, community and kids tables available on a first-come basis depending on prior approval by the market manager and available space.
